

## HOW TO REQUEST DEFERRED DISPOSITION

### You are eligible for Deferred Disposition if:

- 1) You did not possess a Commercial Drivers License at the time of the offense.
  - 2) You have not participated in any Deferred Disposition program during the past one year (calculated from date of previous dismissal to the date of your current citation) in this Court.
  - 3) You are not currently participating in a Deferred Disposition in any other Court.
  - 4) Your violation was not in a construction/work zone with workers present.
- You may NOT be eligible for Deferred Disposition for the following moving violations: Speeding: 25+MPH over limit, traffic-related offenses involving a school bus, or cases in which an accident occurred. You may request Deferred Disposition for only ONE moving violation.

**If you are 24 or younger you will be required to complete a Driver's Safety Course as a condition of your deferral.**

**If you are eligible, you may sign up for Deferred Disposition by sending the following three items to the Court or appearing at the Court on or before your appearance date:**

- 1) Required fee – the same amount as the fine amount listed on your ticket or brochure.
- 2) The Deferred Disposition Request form below (completed).
- 3) The Deferred Disposition Affidavit form below (completed) and notarized.

### DEFERRED DISPOSITION REQUEST

## NOTICE

### DRIVER'S RESPONSIBILITY SYSTEM

“A conviction of an offense under a traffic law of this state or a political subdivision of this state may result in the assessment on your driver's license of a surcharge under the Driver Responsibility Program.”

Chapter 708 of the Transportation Code establishes a Driver's Responsibility System. The system is based on points related to traffic convictions. Moving traffic violations will be assessed two points. Each year DPS will assess a surcharge on the license of a person who has accumulated six or more points during the preceding 36 month period. The Department of Public Safety (DPS) must collect the surcharge and may use automatic license suspension to collect. A No Insurance (Failure to Maintain Financial Responsibility) conviction earns the driver a surcharge of \$250.00 per year. A No Driver's License conviction results in a surcharge of \$100.00. These surcharges will last three years. If you have questions about the driver's responsibility system contact the DPS.

“If you are convicted of a misdemeanor offense involving violence where you are or were a spouse, intimate partner, parent, or guardian of the victim or are or were involved in another similar relationship with the victim, it may be unlawful for you to possess or purchase a firearm, including a hand gun or long gun, or ammunition, pursuant to federal law under 18 U.S.C. Section 922(g)(9) or Section 46.04(b). Texas Penal Code. If you have any questions whether these laws make it illegal for you to possess or purchase a firearm, you should consult an attorney.”

**DIRECTIONS:** The Court is located in the South East corner of FM 1171 (Cross Timbers Rd.) and Kirkpatrick Ln.

Denton/Dallas/Lewisville – Take exit number 452 off Interstate 35E. Go West on FM 1171 to Kirkpatrick Ln. take a left at the light.

Grapevine – Go North on FM 2499 turn right on FM 1171 (Cross Timbers Rd.). When you come to the light at Kirkpatrick Ln. turn right.

### **IMPORTANT INFORMTION:**

Failure to appear in person, by mail, or fax on or before your appearance date may result in additional fines and costs, a warrant for your arrest, denial of your vehicle registration by the Tax Assessor's office, suspension of your driver license and your case being reported to a collection agency.

## YOUR OPTIONS FOR HANDLING YOUR TICKET:

### **OPTION 1 - PLEAD NO CONTEST OR GUILTY AND PAY THE FINE**

- A. IN PERSON - at 4150 Kirkpatrick Lane, between 7:30 a.m. - 5:30 p.m., Monday – Friday. Only the defendant or their attorney may appear on their behalf.
- B. BY MAIL – Circle the appropriate plea on the reverse side of your ticket and sign your name. Mail the ticket along with your check or money order (made payable to the Town of Flower Mound) for full payment. Payment must be postmarked on or before the appearance date on your ticket.
- C. PAY ON-LINE at [www.flower-mound.com](http://www.flower-mound.com) with Visa or MasterCard.

### **OPTION 2 - REQUEST A COURT HEARING**

- A. IN PERSON – at 4150 Kirkpatrick Lane between 7:30 a.m. - 5:30 p.m., Monday – Friday.
- B. BY MAIL – Check the appropriate box on the reverse side of your ticket. Sign your name and fill in your current address. Your date and time to appear will be mailed to you. Your request must be postmarked on or before your appearance date on your ticket.
- C. BY FAX – Fax your request on or before your appearance date on your ticket. The fax number is (972) 874-3379. Please call (972) 874-3370 to confirm receipt of fax. Your date and time to appear will be mailed to you.

Court Hearings **CANNOT** be scheduled by telephone.

The following two options will keep the violation from appearing on your driving record if completed successfully.

### **OPTION 3 - REQUEST DRIVING SAFETY COURSE (DSC)**

### **OPTION 4 - REQUEST DEFERRED DISPOSITION**

### **SPECIAL INSTRUCTIONS FOR JUVENILES**

Juveniles (ages 10-16) **MUST APPEAR IN PERSON WITH A PARENT OR LEGAL GUARDIAN** for a court hearing. A hearing date will be scheduled and a notice will be mailed to the address on the front of your citation. A court hearing is also required to request Driving Safety Course or Deferred Disposition. **DO NOT MAIL PLEA OR PAYMENT TO THE COURT.**

#### JUVENILES

Pursuant to HB 2319(h): You and your parent have a legal obligation to provide the Court in writing with your current address and residence. The obligation does not end when you reach the age of 17. On or before the seventh day after the date you or your parent changes residence, you or your parent shall notify the Court of the current address by completing a “Juvenile Change of Address” form. A violation of this requirement may result in arrest and is a Class C misdemeanor punishable by fine up to \$500.00. The obligation terminates **only** on **full** discharge and satisfaction of the judgment.

**HOW TO REQUEST A DRIVING SAFETY COURSE**

You may be eligible to attend a driving safety course or a motorcycle safety course (if you were operating a motorcycle at the time of the citation) for dismissal of your ticket. You can only take a driving safety course for ONE violation.

**You are eligible for a Driving Safety Course if:**

- 1) You do not possess a Commercial Driver’s License.
- 2) You have not completed a Driving Safety Course for ticket dismissal in the previous 12 months (calculated from date of previous completion to the violation date of your current citation).
- 3) You have a valid Texas driver’s license or permit.
- 4) You have valid proof of insurance showing you as a covered driver.
- 5) Your violation was not in a construction/work zone with workers present.
- 6) Your citation was for a moving violation.
- 7) If cited for speeding, your actual speed must be less than 25mph over the speed limit.

If you are eligible, you may sign up for a Driving Safety Course by sending the following 5 items to the Court or appearing at the Court on or before your appearance date:

- 1) Required fees: \$107.00 for Non-School Zone Violations and \$132.00 for School Zone Violations
- 2) A copy of your valid Texas Driver’s license.
- 3) A copy of your valid insurance showing you as a covered driver.
- 4) The Driving Safety Course request form below (completed).
- 5) The Driving Safety Course Affidavit form below (completed) and notarized.

**COMPLIANCE DISMISSALS**

**You must appear as directed in the Municipal Court of Flower Mound, Texas on or before fifteen (15) calendar days from the date of offense.**

You may request to have up to twenty (20) working days to correct the following violations, expired inspection, expired registration and expired drivers license. Please contact court for more information.

**2. EXPIRED INSPECTION STICKER**

The violation may be dismissed, if the vehicle was inspected, sufficient proof is submitted to the court, **the inspection sticker wasn’t expired for more than 60 days** and the \$20.00 dismissal fee is paid to the court.

Or pay the fine of \$169.00

**3. EXPIRED REGISTRATION**

The violation may be dismissed, if the vehicle was registered, sufficient proof is submitted to the court, **the penalty fee was paid to the tax assessor office** and the \$20.00 dismissal fee is paid to the court.

Or pay the fine of \$169.00

**4. ATTACHING OR DISPLAYING ON A MOTOR VEHICLE A REGISTRATION INSIGNIA THAT IS ASSIGNED FOR A PERIOD OTHER THAN THE PERIOD IN EFFECT**

The violation may be dismissed, if sufficient proof **showing the vehicle had current registration at the time of offense** is presented to the court on or before your appearance date, and the \$10.00 dismissal fee is paid to the court.

Or pay the fine of \$169.00

**5. EXPIRED DRIVERS LICENSE**

The violation may be dismissed, if the **driver’s license was renewed**, sufficient proof is submitted to the court and the \$20.00 dismissal fee is paid to the court.

Or pay the fine of \$169.00

**6. DRIVING WITHOUT LICENSE IN POSSESSION**

The violation may be dismissed, if sufficient proof of a **valid license on the date of the citation** is presented to the court on or before your appearance date and the \$10.00 dismissal fee is paid to the court.

Or pay the fine of \$169.00

**7. NO INSURANCE/FMFR**

The violation may be dismissed, if sufficient proof of a **valid insurance policy on the date and at the time of the citation** is presented to the court on or before your appearance date and after verification from your insurance company.

Or pay the fine of \$314.00  
Subsequent Conviction \$414.00

**8. FAIL TO CHANGE NAME/ADDRESS ON DL**

The violation may be dismissed, if sufficient proof is presented to the court on or before your appearance date and the \$20.00 dismissal fee is paid to the court.

Or pay the fine of \$139.00

OPERATE MOTOR VEHICLE W/O LICENSE PLATES, DISPLAY OBSCURED/ALTERED LICENSE PLATES, VIOLATE DRIVER’S LICENSE RESTRICTION/ENDORSEMENT, DEFECTIVE EQUIPMENTS, NO REGISTRATION STICKER

These violations may be dismissed. A court date must be scheduled and you must appear before the Judge to determine if your citation is eligible for dismissal.
