Vice-Chair Boehner expressed his concerns with pets in supermarkets. Member Hastings stated that Animal Services has not received any complaints of animals in the supermarkets and reviewed the supplemental information provided in the packet.

### **4. Pets on leash – patio’s restaurants**

Discussion was had about experiences of animals inside of restaurants and in restaurant patios that are off leash. Mr. Boehner voiced his concern of the enforcement of those situations.

Member Hastings encouraged patrons of businesses to first address any concerns with the business manager. She explained the general enforcement of laws pertaining to animals inside a restaurant would be handled by Environmental Services, however, if the animal was a risk to human safety or at large and not under the control of the owner, Animal services would address that issue.
