G. CONSENT ITEMS

H. NON-DISCRETIONARY ITEMS

This part of the agenda consists of items are in compliance with all applicable development standards; are not requesting waivers, exceptions or deviations; and do not require a public hearing.

2. RC20-0011 – Mustang Creek Flower Mound Addition: Consider a request for a Record Plat (RC20-0011 – Mustang Creek Flower Mound Addition) to create a non-residential subdivision. The property is generally located north of College Parkway, east of Timberland Parkway, and south of Locke Drive.
3. SP20-0021 – Mustang Creek Estates: Consider a request for Site Plan (SP20-0021 – Mustang Creek Estates) to development a nursing or congregate care facility. The property is generally located north of College Parkway, east of Timberland Parkway, and south of Locke Drive.

I. REGULAR ITEMS

SUP21-0001 – Lakeside Crossing Building 4 (Jesse James Fit) SUP No. 467: Public Hearing to consider an ordinance granting Specific Use Permit No. 467 (SUP21-0001 – Lakeside Crossing Building 4 (Jesse James Fit)) to permit a health club or athletic club use. The property is generally located south of Lakeside Parkway along and between International Parkway and Northwood Drive.
