- The tennis center feasibility study was brought to council and staff to discuss funding options.

- The Easter Egg Scramble took place on Saturday, April 9th at Jake's Hilltop Park.
- Kidfish took place on April 30th at Leonard and Helen Johns Community Park.
- The Concerts in the Park series begins tomorrow night at Heritage Park. The concert series will be held each Friday night in May.
- The Arts Festival will be held Saturday, May 7th at Heritage Park.
- The Father/Daughter Prom will take place this Saturday, May 7th.
- SIMA and Seniors in Motion will hold its annual Elite Chef Competition fundraiser Thursday, May 12th at the Senior Center.
- On Monday, May 30th the Town will host the annual Memorial Day Observance Ceremony at the Flower Mound Senior Center.
- Both the GLASA and FMYSA agreements will expire on August 31st of this year. Per the recommendations of the Youth Sports Task Force, we put out an RFP in late April and are accepting proposal from interested organizations. The deadline to receive proposals is Friday, May 20th.
