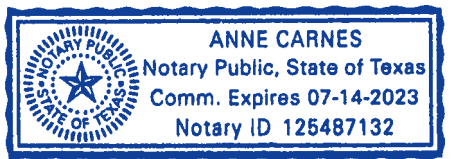

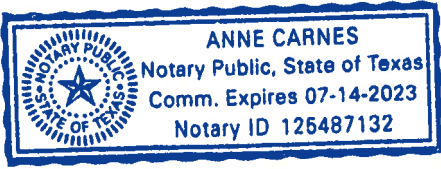
3 Affidavit of Dissolution
