

NEW SINGLE-FAMILY FEES (including duplexes)

- (1) A non-refundable plan review deposit of two hundred and fifty dollars (\$250.00) is due at time of plan submittal.

NEW MULTI-FAMILY FEES (3 attached units or more)

\$500.00 per unit

- (1) A nonrefundable plan review fee equal to 65 percent (65%) of the building permit fee is due at time of plan submittal.

NEW COMMERCIAL FEES

(1) Building Permit Fees for New Construction

- a. 1,000 sq. ft. or less \$450.00 1,001 sq. ft. or more \$330.00 + \$0.12/sq ft
- b. Fees for tenant finish out and shell buildings will be 75 percent (75%) of the above fees.
- c. A nonrefundable plan review fee equal to 65 percent (65%) of the building permit fee is due at time of plan submittal.
- d. Drainage fees must be added to the above totals (see page 3).
- (2) Plumbing, Mechanical and Electrical fees for New Construction (Each)

- a. 1,000 sq. ft. or less \$200.00 1,001 sq. ft. or more \$140.00 + \$0.06/sq. ft.
- b. Fees for tenant finish out and shell buildings will be 75 percent (75%) of the above fees.

FEES FOR ADDITIONS, ALTERATIONS, REPAIRS, DEMOLITION, SCREENING WALLS, RETAINING WALLS OR ACCESSORY BUILDINGS.

The following fees shall be charged for small construction jobs involving additions, alterations and repairs. Projects that involve substantial work shall be charged as new construction at the discretion of the building official.

REGISTRATION AND LICENSE FEES

General, Plumbing, Mechanical, Electrical and Irrigation contractors shall not be eligible to receive a permit within the Town of Flower Mound until they have registered with the Town as a contractor and paid the following fee. Fees shall be paid annually, and registration will be valid from January 1 through December 31. There shall be no proration of fees for registrations occurring after January 1st. Registrations received and fees paid between December 1 and December 31 of any calendar year shall be valid from that date until December 31 of the following calendar year.
